Friendly Reminders

Our service technicians need to be able to access the meter equipment. Please make sure not to crowd or place anything on top of the meter pit, so access is readily available.

When spraying for bugs in your yard, don't forget to spray the outside of the box on your white post. This keeps insects from getting inside and gumming up the equipment. Working together we can keep the operating cost down on your water system.

Water Treatment Plant Update

There are many things that take place behind the scenes at our water treatment plant, in order to keep our water flowing. This year has been no exception for maintenance projects.

Our biggest project included changing out the strainers in one of our four filters. This required removing the sand from the sand filter, replacing the strainers, and then refilling the filter with thirty tons of sand.

Another maintenance item that has to be continually monitored is making sure our wells are functioning at a high capacity. When the wells start slowing down it is necessary to go in and clean the filter to remove any debris that may be bogging them down. We have found that the air burst technique has been very effective. We were able to apply this process to two of our wells this year, giving us a prolonged life expectancy for these wells.

We were also able to bring in a company to successfully rehab eight sewer man holes in Crawfordsville.

We accept **Cash**, **Check**, **or Money Order**. Payments need to be made via mail or dropped off at the WRWA office in Ottumwa. **We do not accept Debit/Credit Card payments** and do not take payments over the phone.

We do offer a Direct Payment Program.

It can be found under the Customer info tab located at the top of the home page. This program allows us to auto withdrawal your monthly payment directly from a bank account so you never miss a bill payment.

News from the Construction Crew

2017 was a busy year for installations and repairs to our water service area. With the drought conditions, many new services were needed to keep farms and residential areas from going without water. Our construction crew installed 46 services throughout the system.

Our Fairfield water tower was re-furbished and painted during the fall this year.
