Wapello Rural Water Top Five Finalist at National Best Tasting Water Competition

The 23rd annual Great American Water Taste Test (GAWTT) was held in Washington, D.C. on March 30, 2022. Throughout the year, utilities from across the country vie for a spot to represent their state during the National Rural Water Association's Rural Water Rally each year. GAWTT is the nation's most prestigious competition for the best tasting water in the United States.

Each state holds their own competition at their annual conference and the winner of the statewide contest moves on to compete in the GAWTT. NRWA received 37 entries from across the country. Wapello Rural Water was honored to be Iowa's representative for this year's rally. During the Rural Water Rally, the preliminary judging narrowed the field of contestants to the top five.

Wapello Rural Water is delighted to announce that we were one of the top five finalists selected. While we didn't win the competition, we were thrilled that our sample was selected as one of the top five in the nation.

We are extremely proud of our staff for their dedication to the Association. Rate Increase for 2023

Maintaining dependable service at an affordable price remains one of our top priorities as an organization. While accomplishing this goal, we must also protect the integrity and financial stability of the Association. Rate increases are needed to continue to provide our customers with safe, high quality drinking water and related services.

The Board of Directors of WRWA has found it necessary to implement an increase of 3% to your water rate. The last time WRWA had a water rate increase was January of 2015. This new rate increase will be reflected on your January 27th, 2023 statement with payment due February 1st, 2023.

While virtually all aspects of our operations have experienced steady cost increases, we pride ourselves on avoiding routine or annual adjustments. We remain committed to protecting our water sources and being proactive in planning for all your future water needs.
